STATEMENTS OF UNDERSTANDING: Please read the following statements and initial in the spaces provided.

- ___ I certify that I have met or will meet with a counselor to assure compliance with my educational objective.
A VA Educational plan must be on file prior to certification of second semester (unless student has completed 30 units). Once a Plan is completed, prior credit will be reported to VA Regional Office.
- ___ I understand that I must submit a Request for Certification every semester prior to the VA certifying Official reporting my enrollment to the VA.
- ___ I understand that the VA does not pay for “recommended classes”, repeats of “D” or better, Incompletes, challenged classes, or any class that is not part of my current Education Plan. Failure to take the proper classes will result in an overpayment and the reduction or termination of benefits. Veterans and Dependents assume full liability for any overpayment of veterans’ benefits.
- ___ I understand that it takes 4 to 8 weeks for the VA Regional office to process my educational benefits. Payment is paid retroactive to the beginning of the semester and is paid according to my dates of attendance.
- ___ I have provided or will provide official transcripts to the FLC Records Office for all of the colleges I have attended and listed above. NOTE: Failure to submit official transcripts will cause automatic decertification of VA benefits as of first day of 2nd semester.
- ___ I will promptly notify the FLC VA Certifying Official of any classes that I add, drop, or stop attending during the semester.
- ___ If I am concurrently enrolled with another college/university, I must notify both FLC and the other college/university. The “Parent” school will be where I receive my degree.
- ___ In order to be certified, I must maintain Satisfactory Academic Progress. This means maintaining at least a “cumulative” 2.00 GPA for undergraduate work.
- ___ Failure to comply may result in termination of VA educational benefits.
