<b>Federal Pell Grant</b>	Be Enrolled: No unit requirement	Grant: does not have to be repaid	For undergraduates with exceptional financial need who have not earned a Bachelor's degree or higher; limited to a lifetime award for up to six years (12 Full-Time semesters or the equivalent), or 600%.	up to \$7,395
<b>Federal Supplement Educational Opportunity Grant (FSEOG)</b>	6 units	Grant: does not have to be repaid	For undergraduates with exceptional financial need; Federal Pell Grant recipients with zero EFC take priority; funds depend on availability at school (Apply early by March 2 <sup>nd</sup> deadline!)	\$100-\$600
<b>Federal Work-Study</b>	6 units	Money earned while attending school; does not have to be repaid	For undergraduate students: jobs are available to students while in school at a pay rate of \$15.50/HR. <b>View Job Opportunities &amp; Apply online at: <a href="#">HandShake</a></b>	up to \$9,000 or up to Unmet Financial Need; whichever is less
<b>Direct Subsidized Loan</b>	6 units	Loan: must be repaid with interest	For undergraduate students who have financial need; U.S. Department of Education generally pays interest while the student is in school and during grace and deferment periods; student must attend at least half-time; 5.50% rate.	Up to \$3,500 or \$4,500, depending on grade level and dependency status.
<b>Direct Unsubsidized Loan</b>	6 units	Loan: must be repaid with interest	For undergraduate students; borrower is responsible for all interest; financial need is not required; 5.50% rate.	Up to \$6,000, depending on grade level and dependency status

<b>California College Promise Program (Los Rios Promise)</b>	12 units	Fee Waiver: Does not have to be repaid	The Los Rios Promise Program covers the cost of tuition for eligible students for up to two consecutive award years. Students must maintain full-time enrollment (12 units required, 15 recommended) and have submitted the FAFSA or CADAA by the <a href="#">deadlines</a> .	None: Waives enrollment fees (tuition). Students are still responsible for paying SRF, UTP & Health fees.
<b>California College Promise Grant</b>	No unit requirement	Fee Waiver: Does not have to be repaid	The California College Promise Grant is funded by the State of California to waive enrollment fees (tuition) to California residents or students who meet the AB 540 criteria. Students must meet <a href="#">academic and progress standards</a> to be eligible. <b>Apply online at: <a href="http://www.losrios.edu/ccpg">www.losrios.edu/ccpg</a></b>	None: Waives enrollment fees (tuition). Students are still responsible for paying SRF, UTP & Health fees.
<b>Cal Grant B</b>	6 units	Grant: Does not have to be repaid	Cal Grant B is for students from low-income families who otherwise would not be able to pursue higher education. For most first-year recipients, the award helps with living expenses, books, supplies, and transportation, but not tuition and fees. If renewed after the first year, a Cal Grant B can be used for tuition and fees at a 4-year institution.	<ul style="list-style-type: none"> <li>Up to \$1,648</li> <li>Up to \$6,000 (For Student with Dependents under the age of 18). <b>Cal Grant C</b>	6 units	Grant: Does not have to be repaid	Cal Grant C helps vocationally oriented students acquire marketable job skills. Full or half-time training must lead to a recognized occupation goal: diploma, associate degree, or certificate.	<ul style="list-style-type: none"> <li>Up to \$1,094</li> <li>Up to \$4,000 (For Student with Dependents under the age of 18). Annual certification required on WebGrants 4 Students at: <a href="http://mygrantinfo.csac.ca.gov">mygrantinfo.csac.ca.gov</a>)</li> </ul>
<b>Chafee Grant</b>	6 units	Grant: Does not have to be repaid	The Chafee grant is free money for current and former foster youth who have not reached their 26 <sup>th</sup> birthday as of July 1 of the award year for college and career training.	Up to \$5000
<b>Student Success Completion Grant (SSCG)</b>	12+ units	Grant: Does not have to be repaid	SSCG encourages full-time attendance and successful on-time completion. It is offered to only full-time Cal Grant B or C recipients.	<ul style="list-style-type: none"> <li>Up to \$2,596 (Enrolled 12-14.99 units/term)</li> <li>Up to \$8,000 (Enrolled 15 or more units/term)</li> </ul>
